Dear Parent/Carer,

I hope this letter finds you and your family well.

I am writing to inform you about some upcoming changes to our school uniform that will take effect at the start of the new academic year (September 2024). After careful consideration and consultation with staff, students, and parents, we have decided to update certain items of the school uniform to ensure they are comfortable, practical, and reflective of our school's identity.

Changes to the School Uniform:

Blazers/Jumpers

We are phasing out the school MET blazer. It will remain an optional part of the school uniform for 2024-25 but will not be school uniform from September 2025. Navy jumpers with the MET Logo will be compulsory from September 2025 and are optional from September 2024.

From September 2024 your child MUST wear either a MET blazer or a navy Jumper with the MET logo. Both can be worn if your child wishes.

Parents/carers of new Year 7 students should purchase the navy jumper with the MET logo and NOT the MET blazer.

Trousers/Skirts/Shorts

Students will have the option to wear either charcoal shorts (these can be bought from any outlet if they conform to our uniform standards), a black pleated skirt* (must be bought from Monkhouse) or black trousers (these can be bought from any outlet if they conform to our uniform standards). This offers more flexibility and comfort while maintaining a unified look.

* Please note, wearing ankle length skirts for religious or cultural reasons, will still be permitted.

Remaining the Same

There will be no change to the following items:

Shoes (can be bought from any outlet)

White Blouse or White Shirt (can be bought from any outlet)

Navy Tie with the MET logo (bought from Monkhouse)

PE Kit (bought from Monkhouse)
