1.4	Minna Koo joined the meeting via Teams at 5.40pm

5.3	SEND Link Visit – JD has completed her SEND Link visit and discussed the SEND parents	
	evening process and communication loop.	
	Safeguarding Link Visit – LW has completed a SEND Link Visit; the report is on Teams.	
	Pupil Premium Link Visit – JH has completed a PP Link Visit; the report is on Teams.	
5.4	The Academy Councillors were reminded to provide a head and shoulders photograph of themselves for the website.

6	Pupil Premium – Ceri O'Sullivan  Presentation shared via screen.	
6.1		
6.2	The PP strategy is a three-year plan. It's reviewed annually and published on the academy website.	
6.3	Any student who has been eligible to access Free School Meals, Looked after Children and	
	previously Looked after Children are all eligible for PP funding.	
6.4	PP students are up to 18.1 months behind their non-PP peers, they are more likely to	
	receive suspensions or permanent exclusions, have lower attendance and are more likely	
	to have Adverse Childhood Experiences (ACEs).	
6.5	There are 357 PP students at BMA (32%), the highest percentage is in Y10 (which is also	
	the year group with the highest SEND need).	
6.6	We follow the Education Endowment Fund recommendation for interventions.	
6.7	We are focusing on increasing oral skills, increased vocabulary and reading age. Improving	
	attendance, increasing homework completion, and achieving at least a Grade 5 are all key	
	to our strategy.	
6.8	The strategy has been shared with all staff, an overview document has been provided, and	
	teachers are encouraged to know who their PP students are. We regularly undertake book	
	looks, utilise a vulnerability register, have introduced a belonging strategy and rewards	
	system, have launched ACEs Nimble training, and we've trained staff as Mental Health	
	First Aiders.	
6.9	We use Voice 21 as a partner to support the development of oracy which we use to	
C 10	compliment what we do in the classroom.	
6.10	36% of lessons were classed as bright spots, which is encouraging.	
6.11	Reading ages is an area that we are still working on. The gap between PP and non-PP	
	students has reduced, but less progress has been made towards closing the gap in 2021-22	
6.12	and again in 2022-23.  Are the students self-conscious about reading to adults?	
6.12	We have been developing reading to adults which we use for booster groups. The choice	
	of texts has an impact on the engagement of students.	
6.13	Do the students leave the class to attend the booster group?	
0.10	Yes, we offer booster groups in Maths and English and they are timetabled at the same	
	time as the main lesson but it's a more bespoke provision.	
6.14	Do the students feel that a booster group is stigmatizing?	
	The nurture groups have a good atmosphere and the ability to access learning is key. They	
	go to their class at the same time that their peers go to theirs, they are not removed from	
	class which makes a difference to the perception of booster groups.	
6.15	There was a 4.3% gap between PP and non-PP students at the end of last year, which was	
	slightly larger than the national average. Persistent absence for non-PP students was	
	23.9% and 43% for PP students.	
6.16	Breakfast club is free for PP students and is well attended.

6.17	Attendance YTD is the highest in the CLF and we've had one day this term where our PP attendance was higher than CLF non-PP attendance.	
6.18	Our current attendance is 90.4% for PP students, 94% for non-PP students and 89.9% for both groups across the CLF.	
6.19	We're retained the homework booklet because it's accessible and in Period 7 the children	
	attend the compulsory homework club for non-completion.	
6.20	92.3% of PP students last year are in employment or further education.	
6.21	Our suspension and exclusion data has reduced by 5% since last year but remains disproportionate to our non-PP students.	
6.22	Do you work with Nick Phelps to discuss students who are PP and have SEND?	
0.22	Yes, the hub teachers' provision is run by the SEND leads. Our highest behaviour incidents are for PP students with SEMH, therefore the SENDCo is researching how to better engage	
	that cohort of students.	
6.23	Ceri O'Sullivan left the meeting at 5.55pm	
6.24	Is the PP funding sufficient to cover the cost of the PP provision? It is used to part-fund some of the staffing who then work with our most vulnerable	
	children.	
7	Academy Council Report - CS	
7.1	Some local GPs are signposting to the school as a referral path, is this a local practice?	
	It's not clear if it's specific surgeries, but we can find out via Bromcom data.	
7.2	ACTION: CS to investigate whether there is a pattern of local GPs signposting referrals to the school.	CS
7.3	A parent who is a lecturer at UWE has offered to sponsor a training place for a member of	
,	staff to deliver a support programme.	
7.4	Jo Duffy left the meeting at 6.20pm	
7.5	The mock data was very strong?	
,	Yes, we are pleased with the performance and the PP data is promising but we still aspire for it to be better. They were a stronger cohort on entry but have continued to make	
	strong progress at BMA.	
7.6	Higher Attaining Pupils remain a focus. The LAC data is skewed because it represents one child.	
7.7	Will Business Subjects be dropped from the curriculum?	
1.1	Possibly, because the recruitment field is very challenging. It's not an enabling subject	
	which means it's not required for accessing an A-Level or degree in Business Studies.	
7.8	Why are many black students attaining Grade 4 but not Grade 5?	
7.0	The progress score is higher in the black students than it is for the white students and their	
	attendance is stronger. We will track the data over time to look for trends.	
7.9	Will the PFI underbudgeting, materially affect the running of the school?	
	Yes, because we need to find £79k, but we run with a 1% budget surplus which for BMA is	
	£86k. The error arose because the PFI budget year is April to April and our budget year is	
	September to September and is RPI linked not CPI linked.	
7.10	There is a 10% professional development time target for all staff?	
	This refers to our professional services staff.
